# **Investment approach**

- Seeks to track the performance of the MSCI US Investable Market Materials 25/50 Index.
- Multicapitalization equity in the materials sector.
- The fund employs a passively managed, full-replication strategy when possible.
- If regulatory constraints prevent full replication, the fund uses a sampling strategy to approximate the index's key characteristics.
- · The fund remains fully invested.
- Low expenses minimize net tracking error.

### About the benchmark

- The MSCI US Investable Market Materials 25/50 Index includes stocks of U.S. companies within the materials sector.
- The sector is made up of companies in a wide range of commodity-related manufacturing industries, such as chemicals, construction materials, glass, paper, forest products, and related packaging products, as well as metals, minerals, mining companies, and producers of steel.
- Uses GICS methodology and clearly classified sectors.
- Offers broad representation of the target sector across large-, medium-, and small-cap companies.


