Investment approach

- Seeks to track the performance of the MSCI US Investable Market Consumer Staples 25/50 Index.
- Multicapitalization equity in the consumer staples sector.
- Employs a passively managed, full-replication strategy when possible.
- If regulatory constraints prevent full replication, the fund uses a sampling strategy to approximate the index's key characteristics. (The fund is currently sampling the index.)
- The fund remains fully invested.
- Low expenses minimize net tracking error.

About the benchmark

- The MSCI US Investable Market Consumer Staples 25/50 Index includes stocks of U.S. companies within the consumer staples sector.
- The sector is made up of industries that tend to be less sensitive to economic cycles, such as manufacturers and distributors of food, beverages, and tobacco, as well as producers of nondurable household goods and personal products.
- Uses GICS methodology and clearly classified sectors.
- Offers broad representation of the target sector across large-, medium-, and small-cap companies.

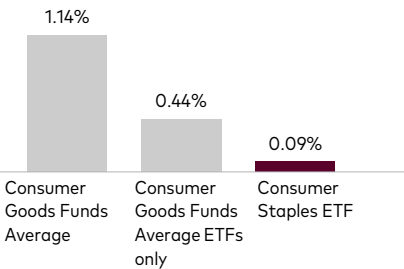
