- The S&P MidCap 400 Value Index represents the value companies of the S&P MidCap 400 Index. (The S&P MidCap 400 Index is composed of mid-cap stocks from the broad U.S. equity market.)
- Tracks the value companies of the S&P MidCap 400 Index as identified by three factors: book value to price ratio, earnings to price ratio, and sales to price ratio.

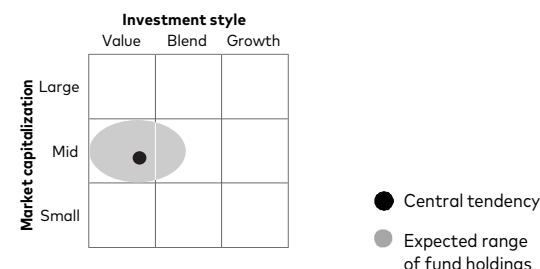

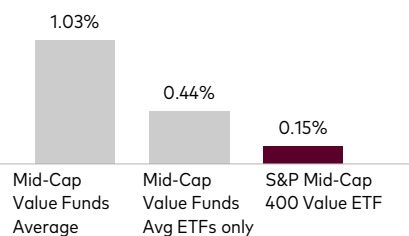
