- Tracks the value companies of the S&P SmallCap 600 Index as identified by three factors: book value to price ratio, earnings to price ratio, and sales to price ratio.

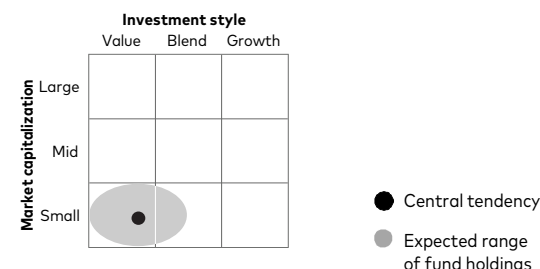

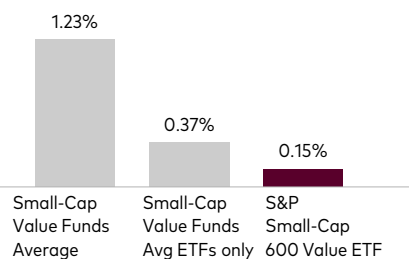
