- The S&P SmallCap 600 Value Index represents the value companies of the S&P SmallCap 600 Index. (The S&P SmallCap 600 Index represents the small-cap segment of the U.S. equity market.)
- Tracks the value companies of the S&P SmallCap 600 Index as identified by three factors: book value to price ratio, earnings to price ratio, and sales to price ratio.

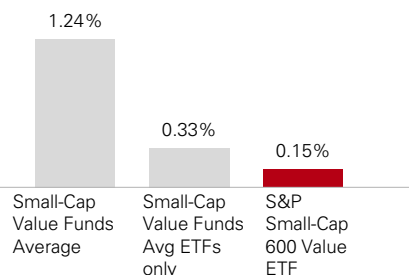
