- The Russell 1000 Value Index measures the performance of the large-cap value segment of the U.S. equity universe.
- It includes those Russell 1000 companies with lower price-to-book ratios and lower expected and historical growth rates.

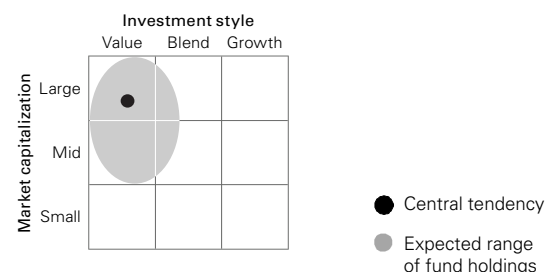

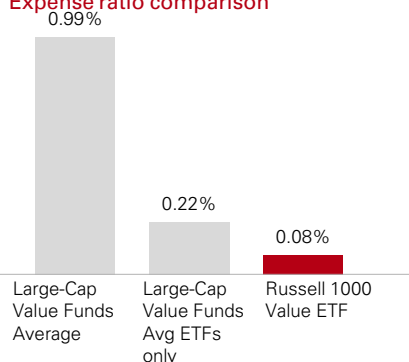
