- The Bloomberg Barclays U.S. Long Government/Credit Float Adjusted Index measures the investment return of all medium and larger issues of U.S. government, investment-grade corporate, and investment-grade international dollar-denominated bonds that have maturities of greater than 10 years and are publicly issued.

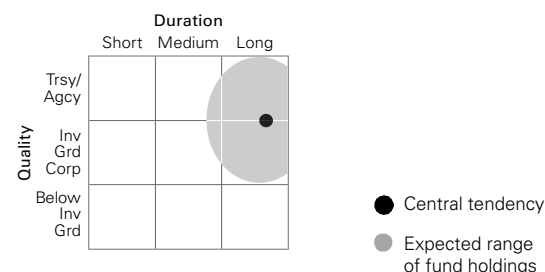

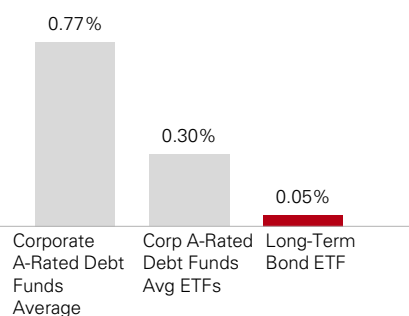
