- Large-cap growth equity.
- Employs a passively managed, full-replication strategy.
- The fund remains fully invested.
- Low expenses minimize net tracking error.

About the benchmark

- The CRSP US Large Cap Growth Index represents the growth companies of the CRSP US Large Cap Index. (The CRSP US Large Cap Index represents the universe of predominantly large-capitalization companies in the U.S. equity market.)
- The index is designed to accurately represent the large-cap growth segment of the U.S. equity market and deliver low turnover.

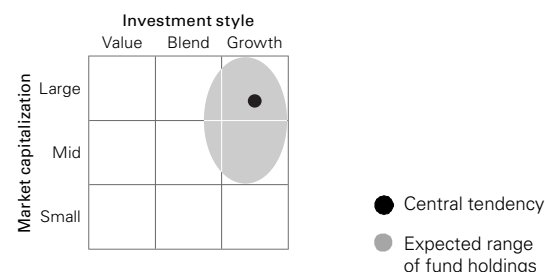

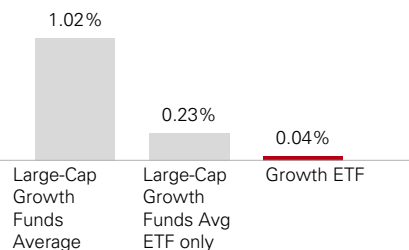
